EXPRESSION OF INTEREST (EOI)

For

Evolving methodologies for handling, processing, scientific disposal and utilization of silt (mixed with municipal waste) from various drains under the jurisdiction of Flood Circle-I, I&FC Department.

1. INTRODUCTION

The Office of the Executive Engineer, Civil Division- III, Irrigation & Flood Control Department (I&FC), Government of NCT of Delhi (GNCTD), invites Expressions of Interest (EOI) from reputed, experienced, and technically competent agencies/organizations engaged in legacy waste management, bio-mining, and bioremediation.

The initiative aims to address the huge quantity of silt taken out from the various drains having mixed flow through adoption of ecologically sustainable and scientifically proven remediation latest technologies for handling, processing, scientific disposal and further utilization of silt.

The project is proposed to be implemented under a Design-Build-Operate (DBO) model, wherein the selected agency shall be responsible for design, installation, operation, and maintenance of the processing system.

2. BACKGROUND

The Flood Circle-I, I&FC Department is the responsible agency for the management of major drainage systems and flood control infrastructure in Delhi. The Irrigation and Flood Control (I&FC) Department maintains approximately 15 drains carrying a mixed flow of stormwater and sewage.

Approximately 4,00,000 MT of silt mixed with municipal waste is generated annually during desilting operations in Flood Circle-I. Over time, the Department has been disposing of the silt for banking, filling up depression areas, disposal at municipal/designated sanitary landfill sites, or by allowing the contractor to take away the silt at his own cost upon payment of royalty to the Department.

However, with the passage of time, saturation has been achieved at the locations of available depression areas as well as designated/MCD landfill sites.

To address these challenges, the Department intends to engage expert agencies for adopting scientific, environmentally compliant, and ecologically sustainable solutions for the disposal and reuse of dredged material.

3. OBJECTIVE

The objective of this EOI is to identify suitable agencies capable of developing scientifically sound, environmentally sustainable, and economically viable methodologies for treatment, disposal, and utilisation of silt, sludge, and waste material from drains under FC-I, I&FC jurisdiction.

5. PROJECT OVERVIEW

The Executive Engineer, Civil Division- III acts as the Division Office on behalf of Flood Circle-I, I&FC Department, GNCTD for the project.

The project envisions establishment of modern waste processing systems for largescale remediation of silt extracted out from various drains with focus on:

- i. Sustainable waste management
- ii. Environmental protection
- iii. Adoption of advanced technologies

6. SCOPE OF WORK

The selected consultant/agency shall undertake, but not be limited to:

- i. Assessment of existing de-silting and waste handling practices
- ii. Physical and chemical characterization of dredged material
- iii. Development of suitable treatment and reuse methodologies
- iv. To promote recovery and reuse.
- v. Ensuring compliance with CPCB, DPCC, and NGT norms
- vi. Preparation of implementation plan.
- vii. Submission of detailed project report (DPR) and recommendations

ELIGIBILITY AND QUALIFICATIONS

- i. The bidder should be a legally registered with central/state/autonomous/PSUs with at least 5 years of experience.
- ii. The bidder should have experience in bio-mining/bioremediation or similar waste management works
- iii. The bidder must have valid GST, ESI & EPF registration.
- iv. The bidder should have an average annual financial turnover of Rs. 8.40 Crores during the immediate last three consecutive financial years.

- v. The bidder should have a net worth of not less than Rs.2.80 crores in the preceding financial year issued by Certified Chartered Accountant with UDIN.
- vi. The bidder should not have been blacklisted by any Government agency

Note:- The value of annual turnover figures shall be brought to current value by enhancing the actual turnover figures at simple rate of 7% per annum.

8. EVALUATION AND SHORTLISTING PROCESS

EOIs will be evaluated based on a technical scoring system. Only agencies scoring a minimum of 75 marks out of 100 shall be shortlisted for the next stage.

The EOI submitted by the agency shall be technically evaluated by the committee decided by the department the participant will be invited for the presentation before the committee. The selection of agency/ies shall be based on following criteria:-
