OFFICE ORDER

Sub.: Debarment of Enlistment for a period of Nine months in respect of M/s **Rahul Construction Co.**, Partner (i) Sh. Vinod Kumar Sharma, (ii) Sh. Rahul Sharma, Add. 23, Main Road, Maujpur, Delhi-110053, in Class-II (B&R category).

1. Whereas, agency M/s **Rahul Construction Co.** Partners 1). Shri Vinod Kumar Sharma and 2). Shri Rahul Sharma vide letter dated 23.10.2024 conveyed that agency is willing to change the address from 23, Main Road Maujpur, Delhi 110053 to C-109, Sector 100 Noida, Uttar Pradesh-201301 and change in constitution of firm from partnership to proprietorship firm and requested to inform the procedure / formalities to be completed as per latest Enlistment Rules.
2. Whereas, the instant case was placed in the meeting held on dated 07.03.2025 and 10.06.2025 of Advisory Committee, wherein the Advisory Committee found that partner Sh. Rahul Sharma is already an enlisted contractor (Class-IV B&R category) in I&FC Department as an Individual on the basis of Educational Qualification i.e. Degree as per the relevant clause 6.1.6 CPWD Enlistment Rules 2022. While submitting the application for enlistment on dated 31.01.2023 as an individual Sh. Rahul Sharma has signed the undertaking given in Annexure-I "that he is not the Director/Partner of the firm enlisted with I&FC Department and any other organization". That the agency M/s **Rahul Construction Co.** (Class-II) and M/s **Rahul Sharma** (Class-IV) had hide the facts and gave false particulars, therefore violated the rules of CPWD Enlistment Rule. Accordingly, the application for prior approval for change in constitution of the firm, M/s **Rahul Construction Company** (Class-II, B&R category) was rejected. The Advisory Committee has recommended that the cases of both the agencies M/s **Rahul Construction Company** (Class-II) and M/s **Rahul Sharma** (Class-IV, on the basis of Graduate Engineer) be placed before the Empowered Committee for taking necessary action as per Rule 13.0 Disciplinary Action of CPWD Enlistment Rules and the Enlistment Authority had accorded approval.
3. Whereas, as per relevant rules for Enlistment of Contractor under Clause 13.0 "Disciplinary Action", the Enlisting Authority has accorded approval for the constitution of Empowered Committee. The matter has been placed before the Empowered Committee, the Empowered Committee has examined and decided to issue a Show Cause Notice to the firm M/s **Rahul Construction Co.** (Class-II, B&R category).

4. Whereas relevant rules for Enlistment of Contractor, under clause (13), Disciplinary action, "The Rules for enlistment of contractor 2024" stipulated that, "*Where the contractor has made himself liable for disciplinary action, the enlisting authority shall have the right to debar the defaulting contractor from participating in tender process for a period not exceeding two years based on the recommendations of Empowered Committee.*"
5. Whereas relevant sub rule 13.6 "Rules for Enlistment of Contractor 2024", provides that "The contractor may be debarred if any of the act, as mentioned under said rule 13.6 at para (a) to (t) is established.
6. Whereas a notice was issued vide this office letter no. T-8(533) CEF/SSW/DB/1999/8192 dated 01.09.2025 to show cause why disciplinary action as deemed fit should not be taken against agency/contractor M/s Rahul Construction Co. Partners 1). Shri Vinod Kumar Sharma and 2). Shri Rahul Sharma and also why should not be debarred / suspension for a period as decided by the Competent Authority as per relevant rules of "Rules for Enlistment of Contractor 2024".
7. Whereas the Empowered Committee is of the opinion that Agency/Contractor M/s Rahul Construction Co. Partners 1). Shri Vinod Kumar Sharma and 2). Shri Rahul Sharma has violated the rules (Rule 13.6) as per Rule 13.0 of "Rules for Enlistment of Contractor 2024".
8. After carefully considering all the facts & circumstances of the case, documents available on record, reply submitted by M/s Rahul Construction Co. and the recommendations of the Empowered Committee, as per relevant Rule 13.6, the Enlistment Authority has decided to debar the Firm M/s Rahul Construction Co. Partners 1). Shri Vinod Kumar Sharma and 2). Shri Rahul Sharma, 23, Main Road Maujpur, Delhi 110053 in Class-II (B&R category) for a period of nine (09) months.
9. This is issued as per direction of Enlistment Authority.
